

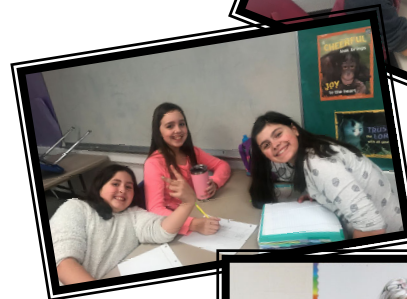


### WCCS Mission

The Extended School Care (ESC) program offers Westminster Catawba Christian School students fun-filled times in a structured, enrichment-oriented environment. The program provides students with many opportunities including active sports, creative arts and crafts, story times, movies, and much more. ESC exists to maintain a secure Christian environment for students Infant through 8th grade during the hours between school and home.

The program is staffed by qualified teachers and assistants, with a student-teacher ratio of no more than 10:1. Dedicated classroom space provides facilities for several multi-grade divisions. Each day students receive a nutritious snack to recharge their energy. In grades one through eight, homework assistance is available and students are encouraged to complete assignments during the designated time.

WCCS authorizes supervision of students from 7:00 a.m. until 6:00 p.m.

**EarlyArrival:** Any student arriving before 7:30 a.m. is considered an early arriver, resulting in a fee. Supervision is available from 7:00-7:55 a.m. each morning.

**AfterSchoolCare:** This service is available on a regular or drop-in basis from 2:40-6:00 p.m. Students registered for regular care are charged based on a fixed monthly fee. Students that use the drop-in care pay an hourly rate and **MUST** make arrangements in advance through the ESC Director to ensure space availability.

## EXTENDED SCHOOL CARE AGENDA

During Extended School Care, students will participate in an appropriate balance of the following activities:

- Snack time
- Homework
- Recreation
- Creative expressions
- Physical activity



## ENROLLMENT

Enrollment is completed online at the same time as class enrollment. Please consider the following guidelines when choosing your registration:

- ESC fees not included in FACTS will be billed monthly and are due by the first of the month. Any invoices not paid by the 10th of the month are considered late and a \$20.00 late fee will be assessed. Hourly and after 6:00 pm late charges are due upon receipt of invoice.
- Credit is not available for days absent.
- Teacher Workdays are included for those students who are registered and attend on a 4/5 day monthly basis. Drop-in services are available for those days at the hourly rate but must be signed-up in advance.
- Sixth through eighth grade students will be transported to the Lower School Campus each afternoon after school and must be picked-up from that location.

### **EarlyArrival 6th-12th Grade**

7:00-7:53 a.m. (no additional charge)

### **After SchoolCare (Monthly fee)**

#### **Infant– Two Year After School**

2:40-6:00 p.m.  
 5 days/week: \$320/month/child

#### **3K-8th Grade After School**

Dismissal-6:00 p.m.  
 4 or 5 days/week \$260/month/child  
 3 days/week \$200/month/child  
 2 days/week \$150/month/child

### **Drop-InCharges (Hourly Fee)**

\$12.00 per hour/child

These are hourly charges for an hour or a fraction of an hour. **Drop-ins are required to make arrangements in writing or by voice mail to the ESC Office at 366-6462 .**

### **LatePick-upCharges**

Late pick-up fees are charged by the minute after 6:00 p.m.

1 - 10 minutes \$1/minute  
 11 - 20 minutes \$2/minute  
 21 - 30 minutes \$3/minute  
 30 - up minutes \$5/minute

For example, a child picked up at 6:13 p.m. would be charged \$16 (\$1 for minutes 1 through 10 and \$2 for minutes 11 through 13).
